CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **JSS College of Education, Sholapur Road, Bijapur-586103, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/2007-2008/4162 dt. 26.08.2008 for conducting M.Ed. (Additional Intake) course of One Year duration with an annual intake of 40 (Forty) students which includes the existing intake of 25 (Twenty Five) students and an additional intake of 15(Fifteen) students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 20.01.2015 and the revised provisional recognition order was issued to the institution on 26.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 405th meeting held on 13th – 14th December, 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause was issued to the institution on 28.12.2021. The institution has submitted reply on 01.01.2022.

4. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as under:-

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **J.S.S College of Education, CTS-5/2,7,8,9, S.S. High School Campus Ward No. 2, City Corporation, Vijayapur-586101, Karnataka** for M.Ed. programme for **1 basic unit of 50 students**”.

5. **NOW THEREFORE**, this order is issued permitting the institution i.e., **JSS College of Education, CTS-5/2,7,8,9, S.S. High School Campus Ward No. 2, City Corporation, Vijayapur-586101, Karnataka** run by **The Bijapur Liberal District Educational Association, Bijapur-586103, Karnataka** for Continuation of recognition for M.Ed. programme for two-year duration with annual intake of **1 basic units of 50 students** subject to fulfillment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

F.KAR/B.Ed./31/SRO/NCTE/2000-2001/912 dt. 10.07.2000 for conducting B.Ed. Course of One year duration with an annual intake of 100 students from the academic session 2000-2001.
